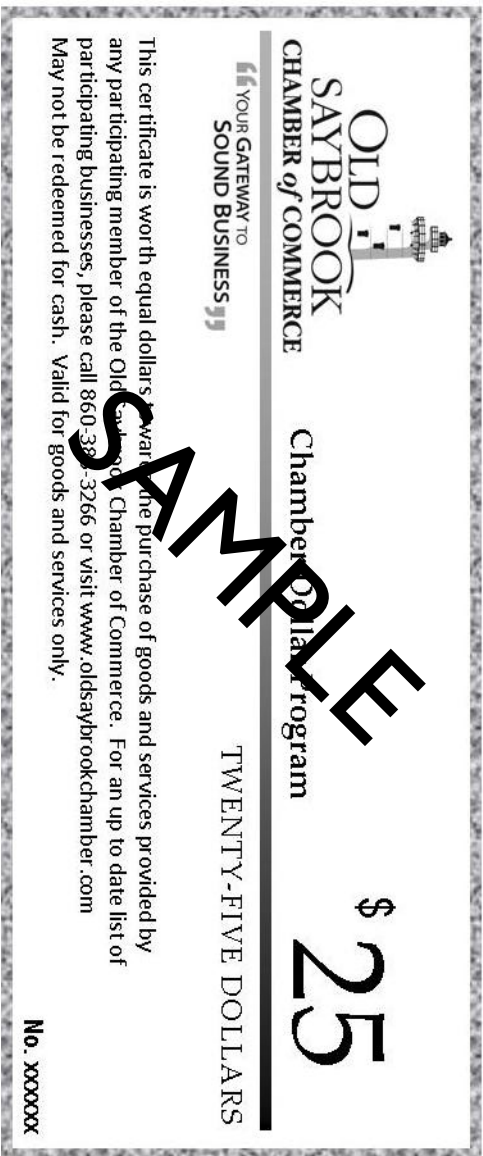

## How It Works

- To participate, the business/organization must be a member in good standing of the Old Saybrook Chamber of Commerce.
- Chamber Dollars are available in \$5, \$10, \$25 and \$50 denominations and can be purchased by cash or check at the Chamber Office, One Main Street, Old Saybrook.
- All Chamber Dollars are numbered and embossed with the Chamber Seal.
- As a Chamber Dollar is presented to your business, honor it, fill in the business name on the back side and return it to the Chamber office for redemption at full face value. Your business will be reimbursed by check within 10 business days.

## How to Participate

- Complete the Participation Agreement and return it to the Chamber Office.

## Details

- There is no fee for the Chamber Dollars program. It is a benefit of Chamber Membership.
- Chamber Dollars will be available for purchase at the Old Saybrook Chamber of Commerce office, One Main Street, Old Saybrook year-round.
- A brochure explaining the program and listing all participating businesses will be distributed with the Dollars.
- Each participating member will be given a window decal announcing “Chamber Dollars Accepted Here.”
